Waiver Term – All residents submitting a Waiver form must also cancel their housing contract in AccessPlus.

- Fall 2010 Semester Only Waiver** - I will be gone all or part of fall 2010 and will return to on-campus housing for spring 2011.
- I will not incur a cancellation penalty for fall 2010 so long as my program participation can be verified.
 - I understand that I am expected to return to on-campus housing for the spring 2011 semester to fulfill the remainder of my contract.
 - If I decide to cancel for spring 2011, the March 1, 2010 cancellation deadline still applies.
 - Beginning December 1, 2010 I can select my own spring 2011 assignment in Access Plus. If I have not selected a space by December 15, a space will be selected for me using the preferences below.
- Spring 2011 Semester Only Waiver** - I lived on-campus fall 2010 and will be gone all or part of spring 2011.
- I will not incur a cancellation penalty for spring 2011 so long as my program participation can be verified.
 - To return to on-campus housing for 2011-2011, I can complete a contract online in AccessPlus in December 2010.
 - If I complete a 2011-2011 contract prior to May 1, 2011 I may chose my own 2011-2011 assignment in Access Plus. After May 1, a space will be assigned for me using the preferences below.
- Both Fall 2010 Semester and Spring 2011 Semester Waiver** - I will be gone both fall 2010 and spring 2011.
- I will not incur a cancellation penalty for 2010-2011 so long as my program participation can be verified.
 - To return to on-campus housing for 2011-2012, I can complete a contract online in AccessPlus in December 2010.
 - If I complete a 2011-2012 contract prior to May 1, 2011 I may chose my own 2011-2011 assignment in Access Plus. After May 1, a space will be selected for me using the preferences below.

Return Assignment Preferences

- I will not return to on-campus housing. I am aware that this does not release me from my spring 2011 contract if I remain a student at ISU.
- I will maintain possession of my current assignment and pay for the space during my absence (fall waivers only).
